4. **NOMINATION PACKETS:** All (6) like packets of the nominees are due to the DCSM's office, Bldg.1118 , Suite , **NLT 1500 hrs 3 March 2007**. The packets will be arranged IAW Fort Carson, SAMC Selection Board SOP and tabbed as indicated in the SOP.

5. **UNIFORM:** Board members will be in ACU's. Nominees & escort NCOs will be in the seasonally appropriate Army Dress Green Service Uniform with all authorized awards, badges and accouterments. Each nominee will also bring his/her **leaders' book**.
