SUBJECT: Off Limits Areas and Establishments

1. **PURPOSE.** To inform all uniformed Armed Services personnel of areas and establishments that are declared Off Limits in Colorado Springs and surrounding areas.
2. **REFERENCE.** AR 190-24, Armed Forces Disciplinary Control Boards and Off-Installations Liaison and Operations, dated 27 July 2006.
3. **APPLICABILITY.** This memorandum applies to all uniformed Armed Forces personnel in the Fort Carson AOR regardless of assignment.
4. This list is current as of 8 May 2014, and supersedes the Off Limits Areas and Establishments memorandum published on 3 February 2014. Changes from the previous memorandum include the following.
 - a. Kiki Smoke, located at 908 North Circle Drive (Colorado Springs), was determined to be closed and was voted to be removed from the off-limits list on 8 May 2014.
 - b. Yolos, located at 460 North Murray Blvd (Colorado Springs), was voted to be placed on the off-limits list via emergency status on 8 May 2014.
5. **OFF LIMITS AREAS AND ESTABLISHMENTS.** All uniformed Armed Forces personnel are prohibited from entering the following areas and establishments within Colorado Springs and surrounding areas.
 - a. **Massage and Spa Parlors:**

 - Yolos, 460 North Murray Blvd, Colorado Springs, CO.


