¹ Soldiers with 18+ years active federal service will not be involuntarily discharged or released from active duty without approval of HQDA. Voluntary chapter 6 or 10 do not have to be referred to HQDA for approval.

² Exception: Recruiting Battalion Commanders (LTC>) are authorized to void enlistments under Chapter 7-15e.

³ Issuance of a discharge under other than honorable conditions requires GCMCA's approval.

⁴ Only the GCMCA may retain a soldier under Chapter 7-17.

⁵ Only when notification procedure is used and no board is convened, otherwise the SPCMCA or GCMCA.

⁶ Honorable discharge may be approved when GCMCA has delegated such authority.
